Is my water safe?

This report is designed to provide details about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. This report is a snapshot of last year's water quality. We are committed to providing you with information because informed customers are our best allies.

Do I need to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as those with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. Where does my water come from?

Our water is produced from six (6) Valley Public Service Authority wells located in the Middendorf Aquifer and purchased from Beech Island Water District.

Source water assessment

Our raw water sources are most susceptible to contamination from runoff or environmental conditions.

Why are there contaminants in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity:

Description of Water Treatment Process

Your water is treated by disinfection. Disinfection involves the addition of chlorine or other disinfectant to kill dangerous bacteria and microorganisms that may be in the water. Disinfection is considered to be one of the major public health advances of the 20th century.

Service Line Inventory Availability

As required by the EPA pursuant to the Lead and Copper Rule, VPSA has completed a Service Line Inventory to identify water service line materials and initiate the replacement of any lead service lines. VPSA has no lead service lines on the utility side, however customers' service lines from the meter to the home are not controlled by VPSA. We have made an effort to identify service line materials on the customer side, but there is still a significant amount of unknowns, which we will continue to work towards identifying.
